Registration Policies

- A completed registration form along with the required paperwork and 2 week security deposit is necessary to process your child's registration and secure their space:
 1. Emergency contact Form
 2. Travel Emergency Form
 3. Release Form
 4. Child/Family History Form
 4. Copy of child's Birth Certificate
 5. Medical Form complete with immunizations and parent & doctor signature
 6. Signature that you have read the parent handbook
 7. Signature that you have read the DCFS licensing form
- A non-refundable, non-transferable enrollment fee of \$150 per child is required at the time of registration to reserve your child's place. Once your child begins classes a 4 week notice is required as per the handbook.
- If you choose to withdraw enrollment within 30 days of this acknowledgement the deposit is fully refundable. On day 31 the deposit is non-refundable.
- Payments are made weekly or monthly and must be paid on Friday or on the last day of the month for the upcoming week/month. Your payment will be prorated based on your child's first day at Mill Creek Early Childhood Program.
